On 11-23-18 after we ate breakfast, Lt. Nesby, two black guards and a hispanic female cameraman brought a Prisoner to F-Pod (lock-up) and put him in 25 cell. An hour or so later an officer brought two red chain bags that had his legal property in it. While the F-Pod door was opened I heard an officer say "Pollock what happend" I then heard a guard admit that he and officer "Williford" tried to break someones jaw and knock their teeth out. When the officer asked who, Pollock then said "Walker in 25 cell." The officer asked what happend, Pollock said "whatever I saw happend, wanna be a witness" The officer said No, I dont witness bullshit. Pollock said "Its only bullshit when ~~officer~~ you get caught, im not new to this" then the door closed. After hearing this I told Walker what I heard and wrote this in support of what I heard.

I reported it several times and nothing is being done about it. I know Jason from articles I read in the past, but I honestly feel that if somethings not done he'll be dead in another month. Gross really? He has a disorder that only allows him to eat certain tray with certain types of food. So its labeled, that makes his food tray palatable. I think something should be done about this. There is a lot of sst that can verify what im saying. Some sort of media outlet or anyone of importance that can get him help should be contacted. He needs the help. Pursuant to 28 U.S.C. 1746 I DECLARE UNDER PENALTY OF PERJURY THAT THE FOLLOWING IS TRUE AND CORRECT;

On 11/12/18 At 10:00 AM on G-13 2 row officer Josaphat Cruzalta GRABBED ME BY THE COLLAR AND PUSHED ME DOWN THE FLIGHTS OF STAIRS WHILE I WAS TALKING TO SGT. LAUREN D. TURLEY. I WENT TUMBLING DOWN AND NEEDED MEDICAL CARE FOR MY NECK AND SPINE. In front of Turley, Cruzalta came running towards me like he would attempt to further harm me, as if pushing me down the stairs wasn't enough. To protect myself I punched him. The picket officer MS. WHITE CALLED FOR ASSISTANCE AFTER I protected myself, but before that her and Turley watched. Turley told Cruzalta not to report anything since he assaulted me, but MS. WHITE still called it in. The only reason Turley wrote a statement is because MS. WHITE didn't go along with the cover-up. I WAS GIVEN ASSAULT CASE for protecting myself, but Cruzalta received NO punishment for initiating the conflict. Assaulting prisoners is a common act by guards because the prison has places everywhere that the camera can't see, but where we have to walk. I WAS PLACED IN SOLITARY CONFINEMENT for the evil actions of a prison guard.
