

This is accomplished through behavior driven programming, which facilitates their reintegration into a less secure environment."

True but sad fact; Altercations, Arguments over petty things occur under this design as stated by Doctor Edgar Schein in "Man against man; Brain washing" in order to produce marked change of behavior and/or attitude, it is necessary to weaken, undermine, or remove the supports to the old patterns of behavior and the old attitudes. Because most of these supports are the face-to-face confirmation of present behavior and attitudes which are provided by those with whom close emotional ties exist, it is often necessary to break those emotional ties. This can be done either by removing the individual physically and preventing any communication with those whom he cares about, or by proving to him that those whom he respects

O.S.P was opened in 1998, Prison officials sent out memo's to all Ohio Prisons to send their, Abst-Confirmer, Alleged gang members, Jail house lawyers, Revolutionaries, to O.S.P to fill its 500 beds Super-max Cells, that cost Tax payers over 80 million dollars to build. but Ohio had for over 30 years housed its super-max prisoners in J-1, a 20 cell unit at S.O.C.F that never stayed full.




So now Prison officials had to sweep all Ohio prisons to fill those 500 super-max cells, prisoners from minimum 1, 2, medium 1, 2, close security and maximum security prison were gathered up and shipped to Super-max states with no Due Process or notice. In 2000 Convicts united to file a Class Action suit against the Super-max Prison "Austin v. Wilkinson".

The Federal Courts ruled in favor of the Convicts.



Been isolated in this social experiment watching others fail victims to this cruel and vindictive game. I've been classified as SA long timer; given more privileges in hopes to further modify my thought process. I have consistently fought to be released from this Super-max as matter the behavioral modification tactics, my eyes are open to what this is really about. 




Notice of facts, evidence against them, a Right To Call witnesses and appeal Rights to a 3 Person Panel. The Prison started to empty out, it went from 500 prisoners to under 70 in 8 months; Out of the four Cell blocks, only 1 remained open. The Prison officials needed a

MASTER PLAN to Keep Their Super-Max prison open. They decided to send level 4 inmates "MAXIMUM SECURITY" to Fill Those 300 empty beds, This was challenged by The Attorney of The Austin-V-Wilkeson Case, The Federal Judge Ruled That no inmate on level 4 Could be housed at O.S.P without Their written Consent to waive Their Rights, and at anytime They Could Request to leave O.S.P.

Once this tactic came to the light the state decided to fill up the 2 remaining blocks up with the Death Row prisoners from ~~O.M.A.N.C.I.~~, now the Super-max was running at




a proper level of Prisoners. Once The Federal
lawsuit was over and done with Prison officials
Revealed Their True Master plan. They moved
out all The Death Row prisoners to chillicothe
prison, and started shipping in 4b and 4A inmates

Demanding Transfer out of O.S.P under



This is The struggle Ohio prisoners now have before them. I believe first they as a whole must understand the true nature and design of the confinement by the powers that be. On April 22, 1961 The Federal Prison Services, Executive Development Program, Symposium, took place, The Topic was "The Power to change Behavior", conducted by the Bureau of Prisons at an associate warden Training Program. They go on to say "effective Treatment of individuals confined in Correctional institutions depends upon the degree to



As it stands O.S.P has 4 housing units, A-block, B-block, C-block and D-block, only one block houses super-max convicts around 80, there are over 300 level 4 inmates housed at O.S.P, 5 level 1 minimum and around 6 Protective Custody ("P.C") inmates. 
At anytime, Imagine in a perfect world all

Freeing the level 5 Comrades to level 4




Prisons? yes I ask you who really is keeping


enlighten them to how much better it is on
